- closest highway is A3 in Satu Nou (19 km near Bors 2)

- closest international seaports: Koper (SLO) 825 km, Constanta (ROU) 796 km, Thessaloniki (GRE) 914 km.

Local Tax incentives

- Exemption from paying building tax
 building tax: 0.95% from the book
 value of the building/year
- Exemption from paying land tax
 land tax: 0.16 euro/sqm/year
- Reduced building permit fees

Incentives

Non-refundable cash subsidies – state aid schemes -

Scheme for assets:

- minimum 1 million investment
- eligible costs: acquisition/production of assets and rent expenses for investment construction
- intensity: 50%

Scheme for salary costs:

- minimum 100 new working places
- eligible costs: net salary and all related taxes for a period of 2 consecutive years
- intensity: 50%



National Tax incentives:

➢Profit tax exemption for reinvested profits

Research & Development incentives (deduction of 50% of the eligible expenses for R&D activities; accelerated depreciation for devices and equipment used in the R&D activities)

≻Income tax exemption for IT experts

8. Business Incubator - CRESC

- Location: Oradea, Louis Pasteur Street, no. 28, in the vicinity of city center
- Value of the investment: 3,6 million euro (50% european founds) building rehabilitation
- The surface of the building: 2.200 sqm
- Facilities: 6 workshops, 2 prototyping workshops, a painting workshop, an architecture office and design workshop, 17 offices for future residents, 30 workspaces, meeting rooms, conference rooms and multifunctional room.
- Objectives: support new creative companies

9. Science Technology Park:

- Location: Oradea, Ceyrat Street, no. 4, in the vicinity of University of Oradea.





- Value of the investment: 7 million euro construction, utilities, research and technological transfer equipment.
- The surface of the building: 6.000 sqm
- Facilities: offices, utilities, parking, reception, internet network, security, networking.

- **Partners in the project** *"Establishment of Bihor Science and Technology Park"*: The Council of Bihor County, The University of Oradea and Oradea Local Development Agency.

10. Make IT in Oradea

Is an initiative developed by a couple of tech local companies with tech and IT profiles and the local administration through ADLO.

Our purpose is simple and clear: **boost, develop, and promote local IT&C talent and creative startups.**

Currently, Make IT in Oradea is developing and overseeing the development of the first business incubator program in Oradea, to nourish, discover and boost, new tech startups.

The annual budget of the incubator is €300.000 and is provided by the local authorities with the sole purpose to spark the creative and innovative people of Oradea.

11. Public Lighting

Starting with July 14, the Oradea Local Development Agency took over the management of the public lighting service in Oradea

The public lighting network measures 712 kilometers of cables, of which 442 kilometers are overhead and 270 kilometers are buried underground. The system comprises 15,595 poles and 24,428 luminaires.

- Royalty 0,6 euro/sqr/ year

- Security control of load

14. Intermodal Terminal in Development Road - Railway
